- Encroachments/agreements
 - o Gaudio, Beech St., North Branford (NB 4A) Talked to Gaudio and he said everything would be moved in a couple of weeks
 - Bethany, Tennessee Gas ROW (BE 23) Tennessee Gas completed work on the pipeline.
 - Woodbridge, Morris Rd. access for UI (WO 5) Determined that UI had an easement to go up the driveway at 2040 Litchfield Tpk.
 - North Branford, Beech St (NB 4A) Lawyer representing buyer of Marzano property asked if their client could keep the license agreement. We said we would be willing to sign a new agreement with them.
 - Orange, Rt. 34 bridge over Wepawaug River (OR 2) Corresponded with DOT's contractor about a license agreement for them to use a portion of our property for repairing the bridge.

- Invasive plants Worked to improve the green milkweed site with Native Plant Trust staff. Developed plans for bamboo at Marion Dr., North Haven. Took down ailanthus at Mill Rock basins. Vendor slated to remove water chestnut backed out of the job. Designed and implemented herbicide plots in Japanese Stilt Grass in Prospect. New surveyed water chestnut and updated GIS data for 2019. Documented and treated Amur Corktrees at Chamberlain. Met with vendor to have ailanthus at the intersection of Thornton St. and Connolly Pkwy. Cleared away more Japanese knotweed along Davis St. in Hamden. Had Operations mow swallowwort around Lake Rd. at Gaillard. Treated Devils walking stick at the Beech St. timber harvest as experiment.
