## Minutes of June 3, 2020 Meeting

A special meeting of the Nominating Committee for officers of the Representative Policy Board ("RPB") of the South Central Connecticut Regional Water Authority took place on Wednesday, June 3, 2020 via remote access. Chairman man Mongillo presided.

Mr. Mongillo, as acting Chair, called the meeting to order at 5:30 p.m.

On motion made by Mr. Slocum, seconded by Ms. Campbell, and unanimously carried, the committee voted to appoint Mr. Mongillo as Chairman of the Committee.
