International Overdose Awareness Day is a global event held on August 31st each year and aims to raise awareness of overdose and reduce the stigma of a drug-related death. It also acknowledges the grief felt by families and friends remembering those who have died or had a permanent injury as a result of drug overdose. **DID YOU KNOW**:

- Of the more than 72,000 preventable drug overdoses in the country in 2017, more than 47,000 involved opioids.
- Opioids account for the majority of drug-related deaths and in most cases such deaths are avoidable.
- North America continues to experience the highest drug-related mortality rate in the world, accounting for 1-in-4 drug-related deaths globally.

International Overdose Awareness Day spreads the message that the tragedy of overdose death is preventable.
