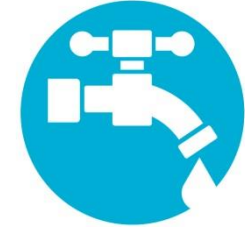

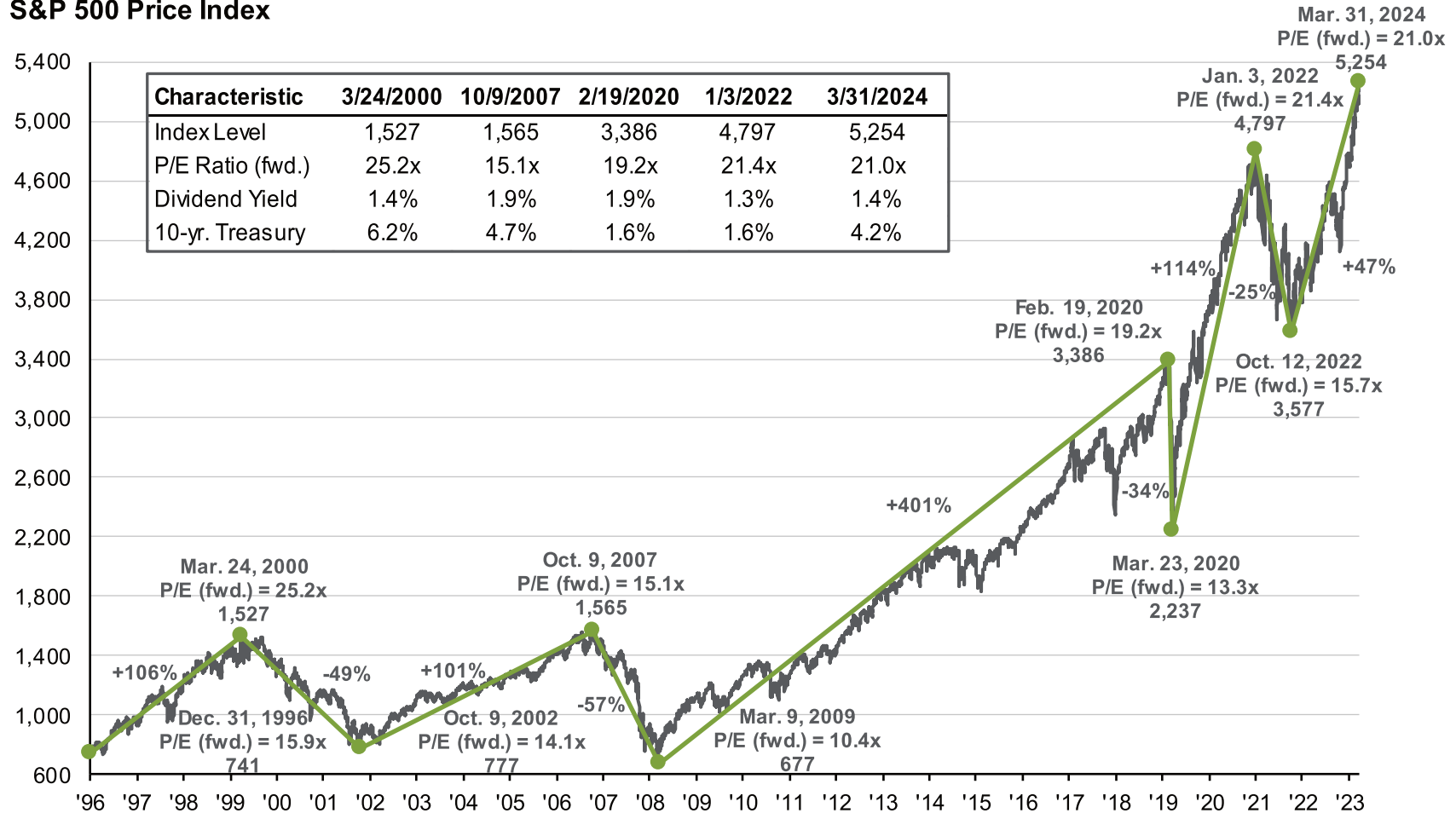




S&P 500 Index at inflection points

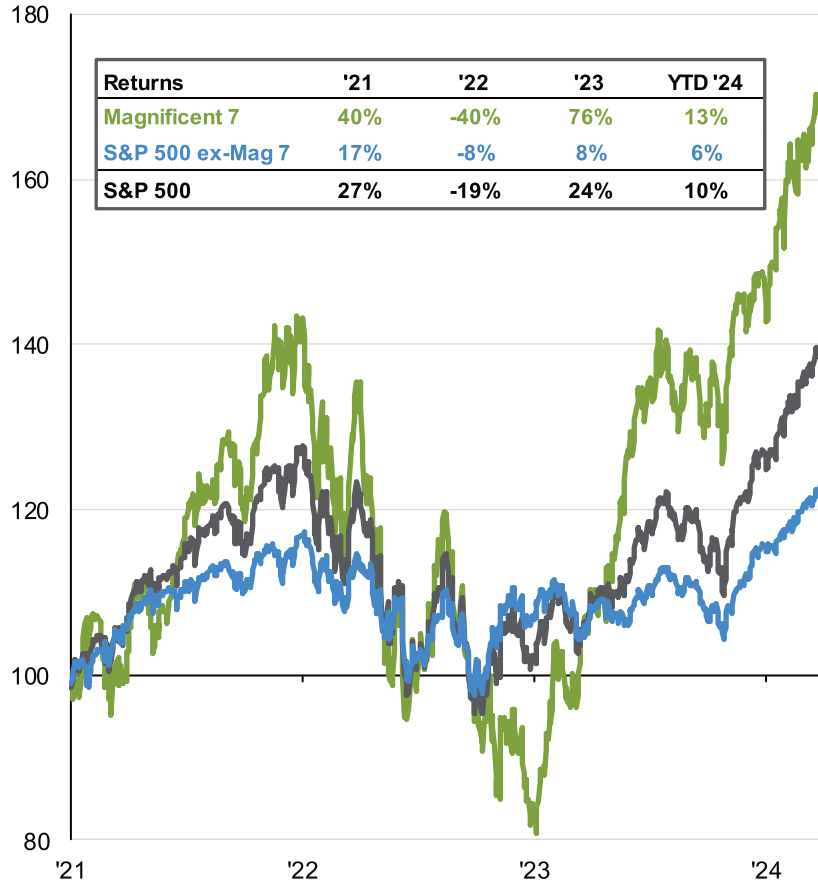


Magnificent 7 performance and earnings dynamics

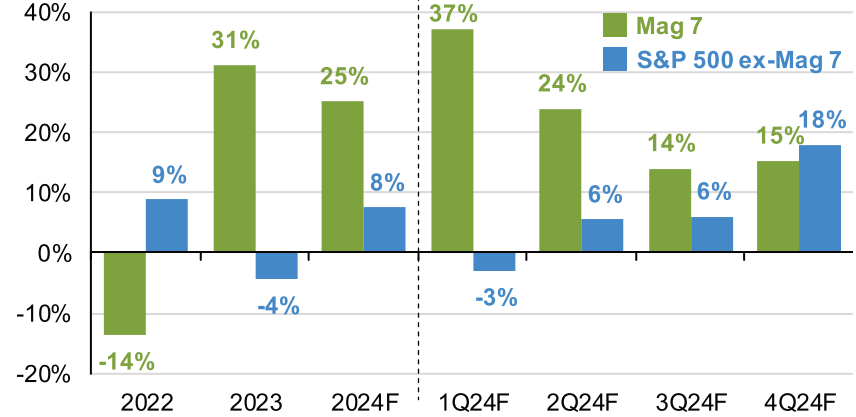
Performance of “Magnificent 7” stocks in S&P 500*

Indexed to 100 on 1/1/2021, price return



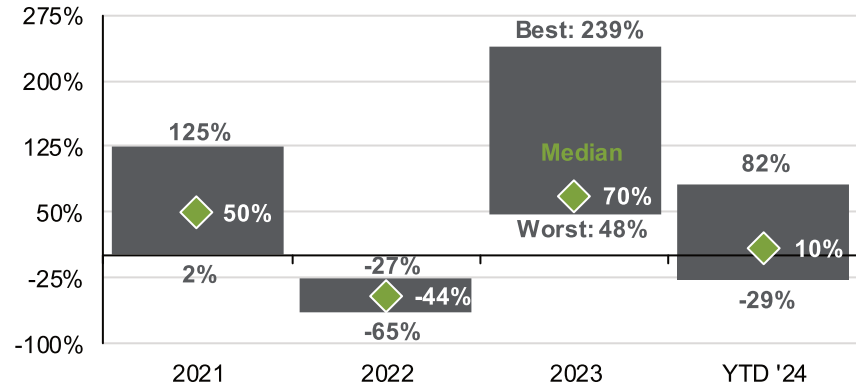
Earnings growth

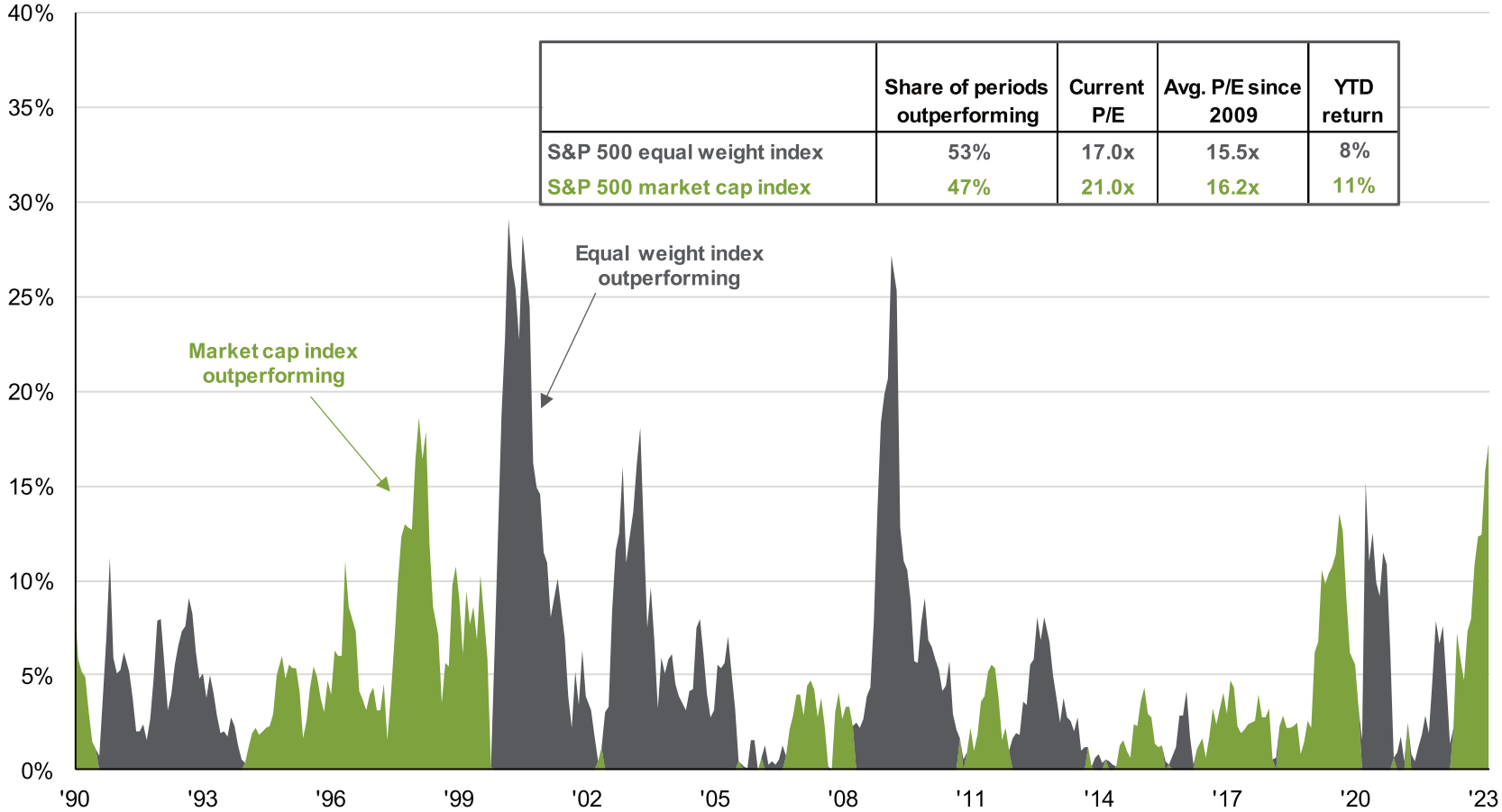

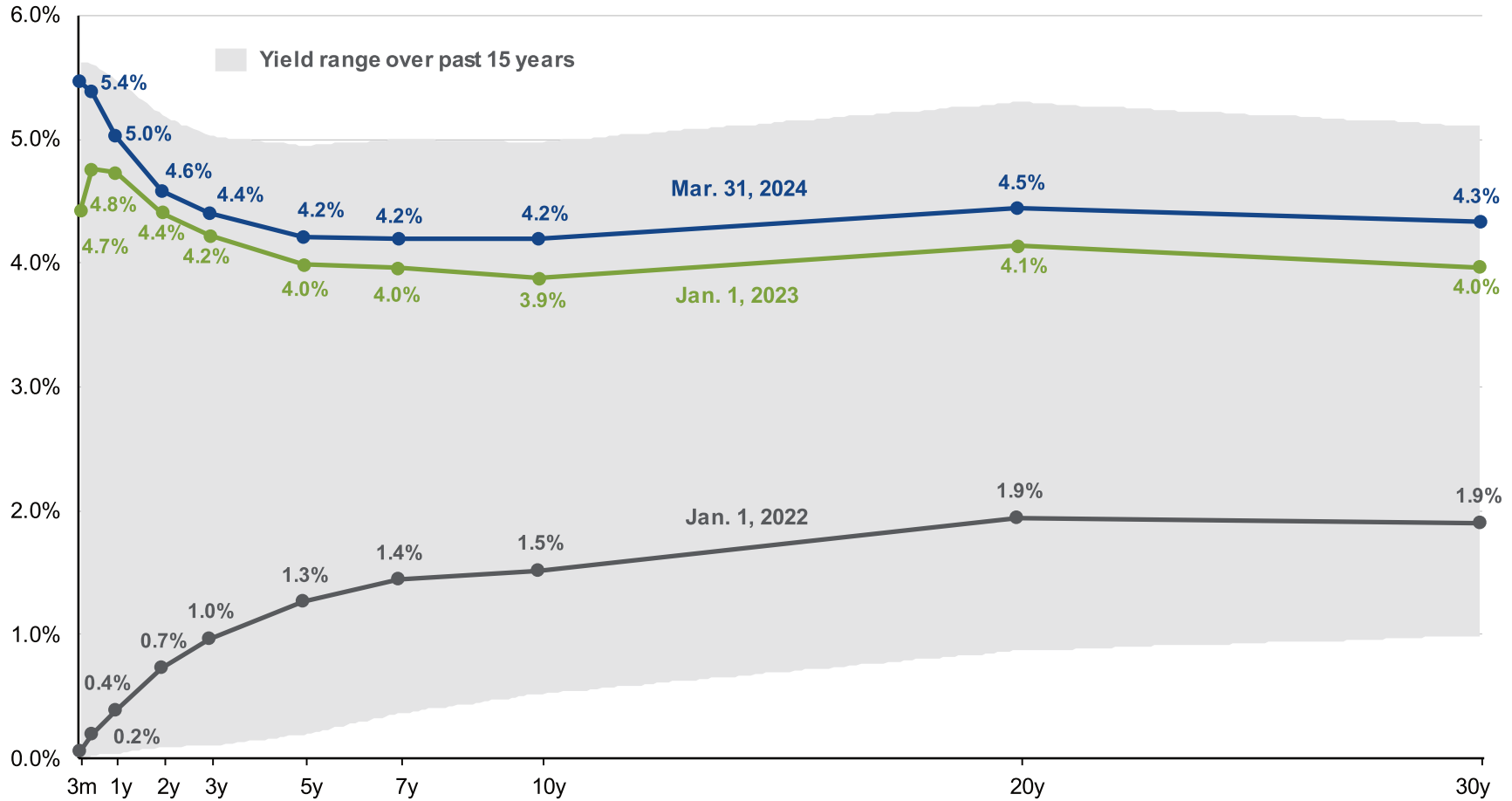




Yield curve

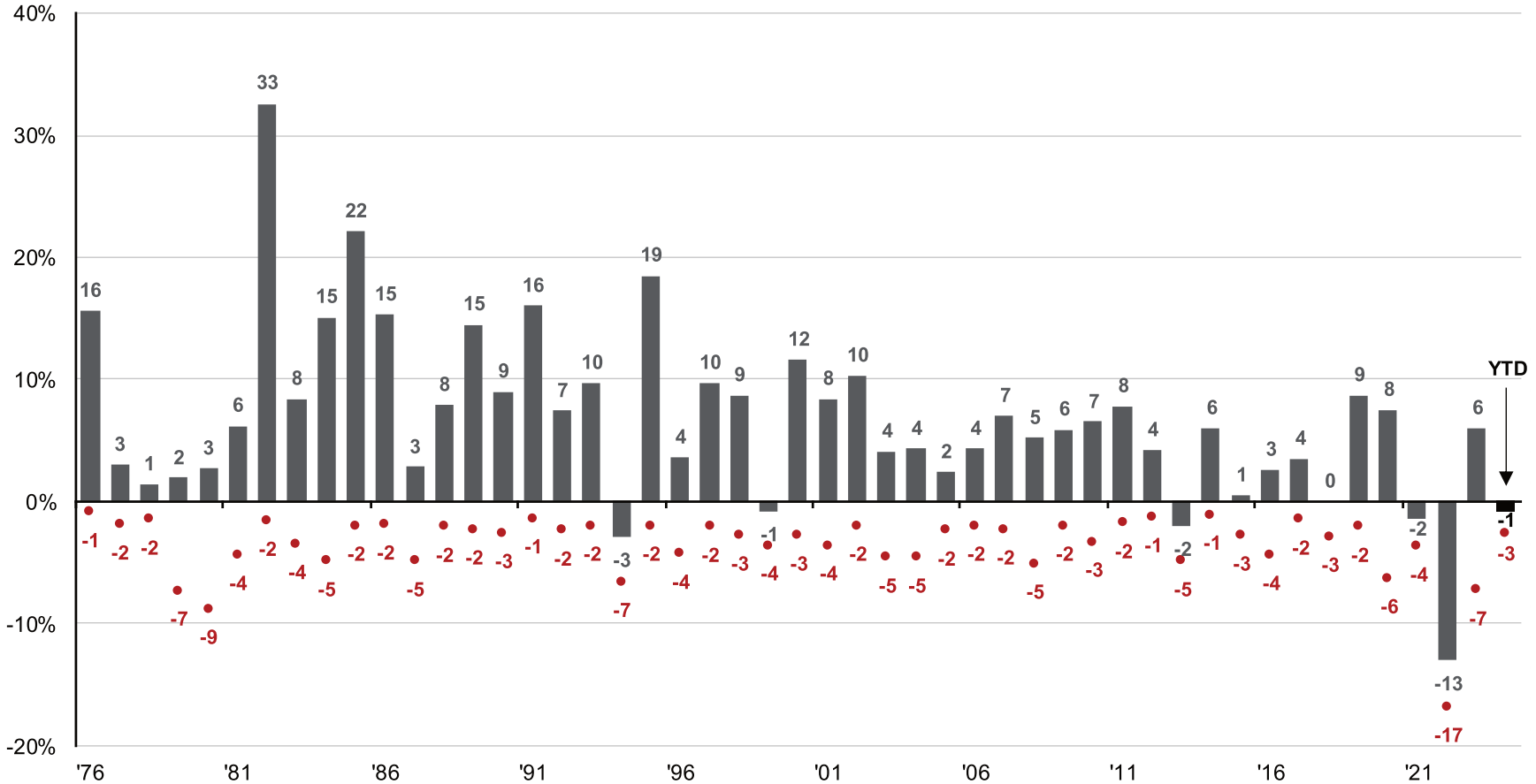
Bloomberg U.S. Agg. annual returns and intra-year declines

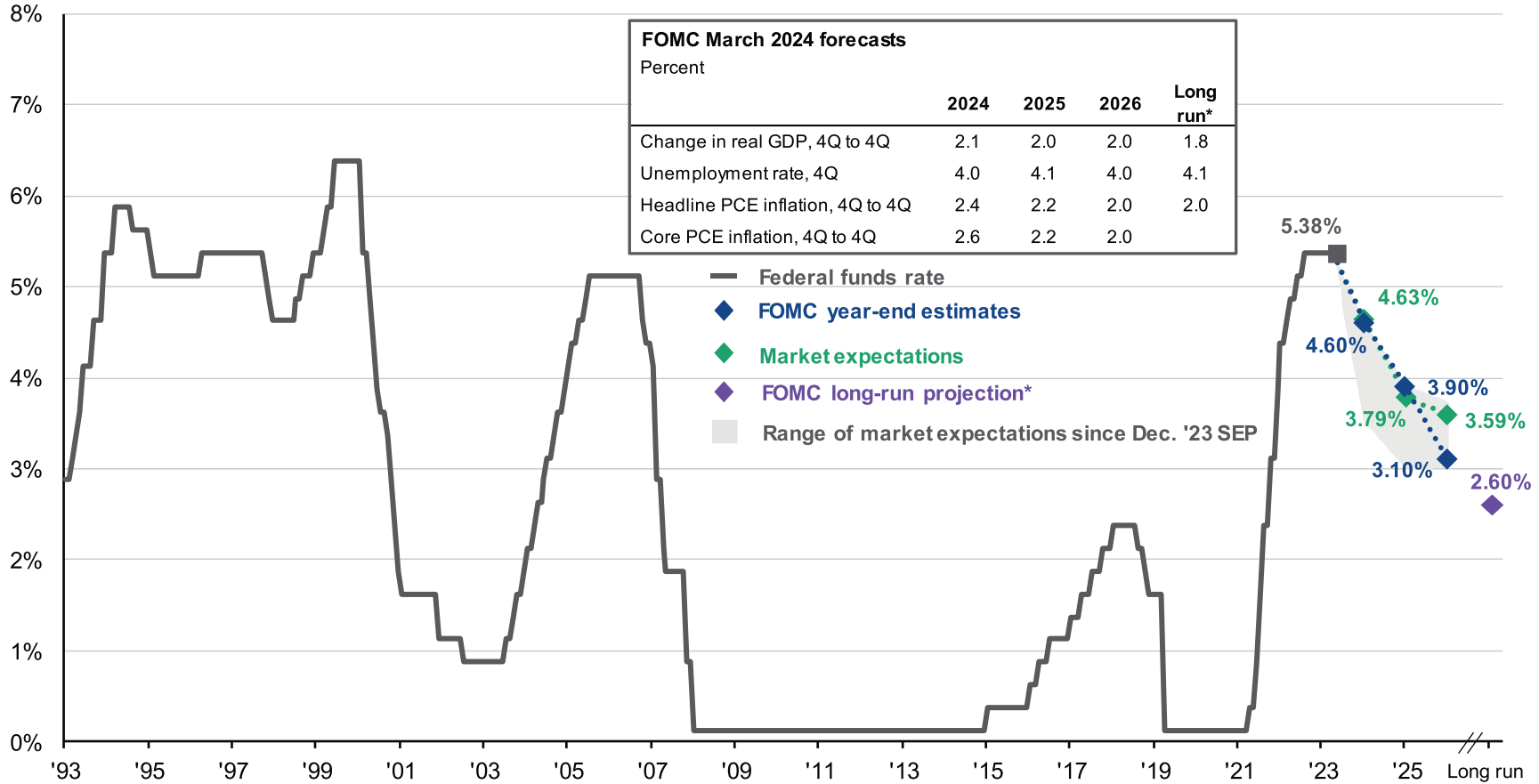

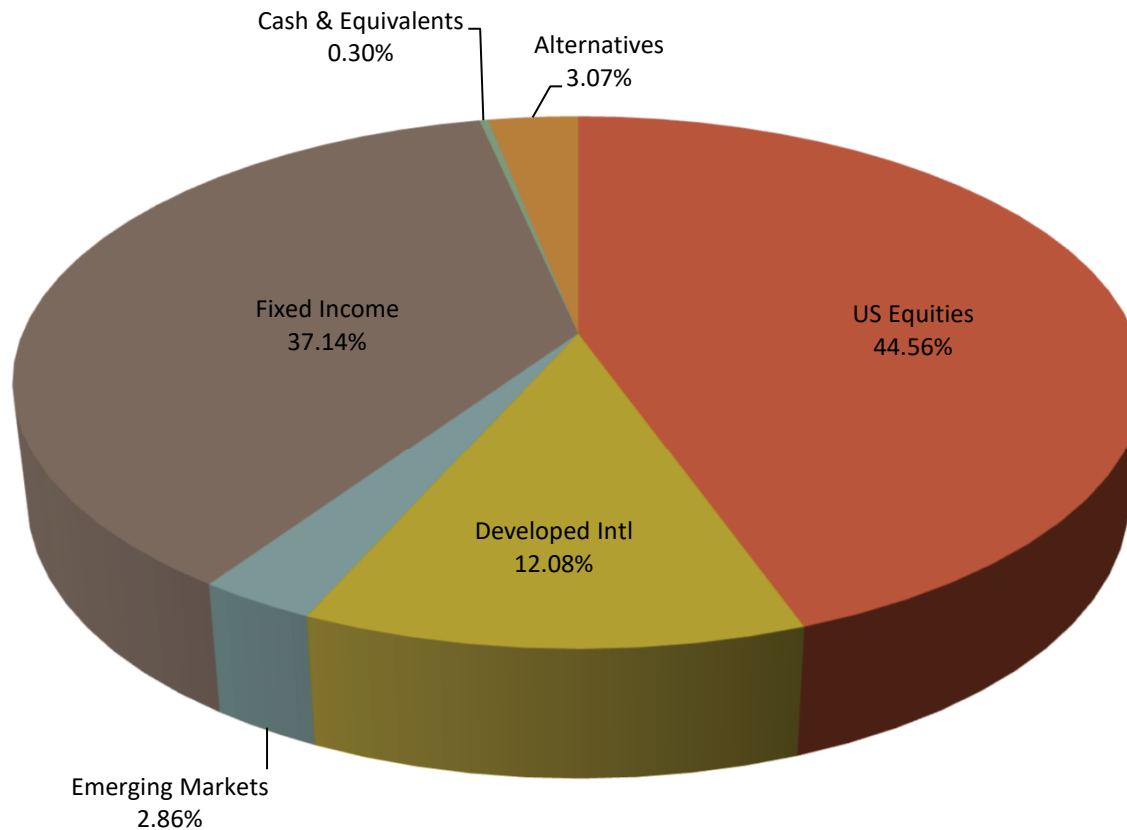

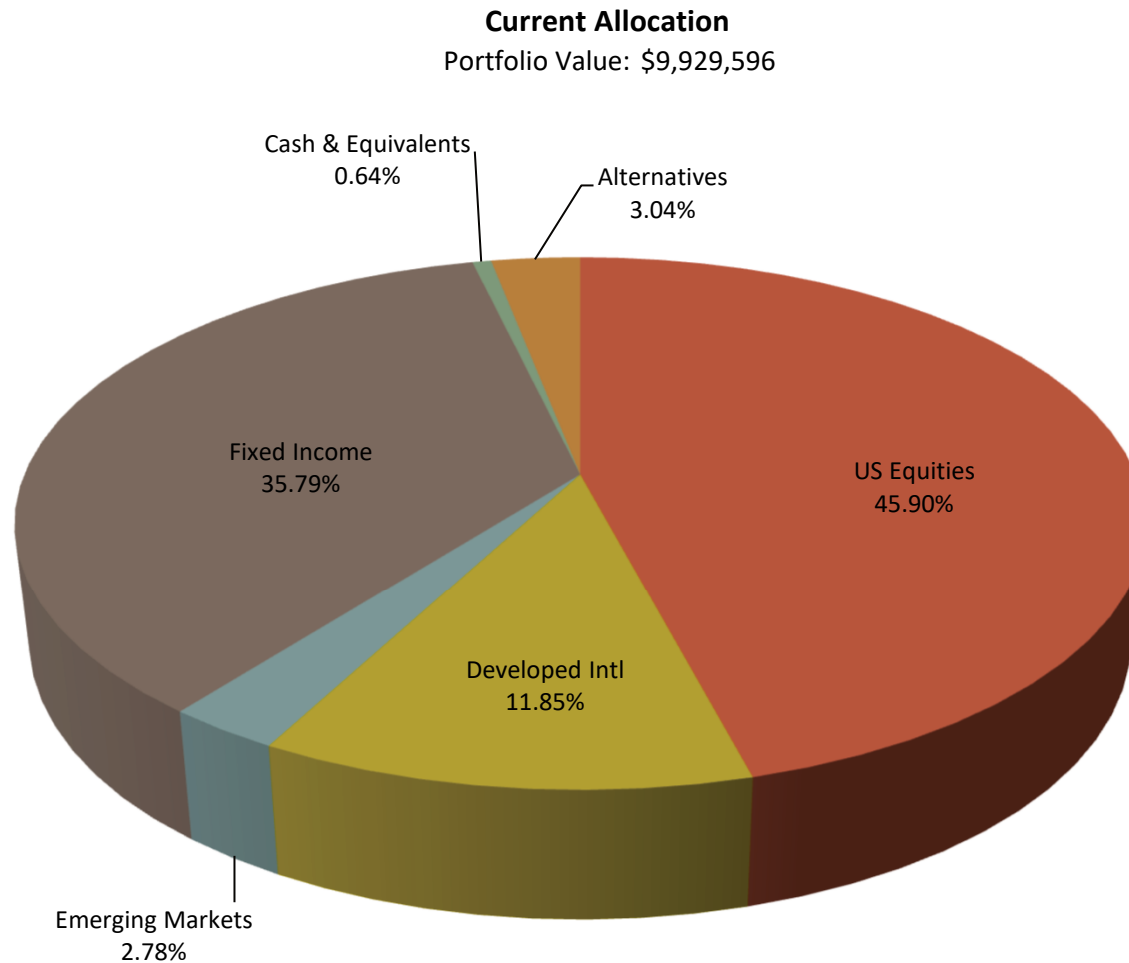

Although there are numerous potential biases that could affect hedge fund returns, we identify some of the more common ones throughout this paper.

Self-selection bias results when certain manager returns are not included in the index returns and may result in performance being skewed up or down. Because hedge funds are private placements, hedge fund managers are able to decide which fund returns they want to report and are able to opt out of reporting to the various databases. Certain hedge fund managers may choose only to report returns for funds with strong returns and opt out of reporting returns for weak performers. Other hedge funds that close may decide to stop reporting in order to retain secrecy, which may cause a downward bias in returns.

Survivorship bias results when certain constituents are removed from an index. This often results from the closure of funds due to poor performance, "blow ups," or other such events. As such, this bias typically results in performance being skewed higher. As noted, hedge fund index performance biases can result in positive or negative skew. However, it would appear that the skew is more often positive. While it is difficult to quantify the effects precisely, investors should be aware that idiosyncratic factors may be giving hedge fund index returns an artificial "lift" or upwards bias.

Minutes of the March 28, 2024 Meeting

A regular meeting of the South Central Connecticut Regional Water Authority (“RWA” or “Authority”) took place on Thursday, March 28, 2024, at 90 Sargent Drive, New Haven, Connecticut and via remote access. Chairman Borowy presided.

The Authority discussed average main breaks as well as valve replacements and exercising. Mr. Bingaman stated that the RWA has implemented a new program to improve valve exercising, flushing, and leak detection. The program includes a budget allocation for valve replacement.

At 12:18 p.m., Mr. Jaser entered the meeting.

Mr. Singh, the RWA’s Chief Information Digital Officer & Vice President of Customer Care, provided highlights of the General Plant.

Mr. Bingaman reported that the five-year capital program is reviewed diligently for efficiency and prioritization. Pursuing grants and the implementation of the asset management program was also discussed.

Authority members discussed rate impact, pre-bidding, value engineering, project choice, consideration, timing and funding, PFAS removal, and the lead service line project.

The status of all capital projects is reviewed monthly. To obtain efficiencies in our capital program, any anticipated unspent funds are reallocated to support reprioritized projects or existing projects.

The attached summary reflects twenty-one amendments. There are fourteen amendments that redistribute funds from one project to another, totaling \$756,500. This redistribution allows for the acceleration of certain projects and/or meets business needs. There are two amendments reflecting capital efficiency transfers to the contingency, totaling \$133,730. In addition, there are five amendments for transfers into the project reserve, totaling \$1,695,000.

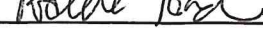

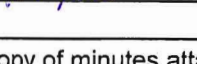

SUBJECT: Capital Budget Transfers – Type B3 Amendments

As prescribed in the Capital Budget Manual, Exhibit 12, Capital Budget Amendment Procedure, Part 1, Type B Amendment, Item 3, Authority approval is required for a transfer of funds from an existing capital account to either another capital account or a newly created capital account if the value is greater than \$500,000.

Filter Media Replacement: This project is being performed in conjunction with the Lake Gaillard Water Treatment Plant Filter Underdrain Replacement project, and because of an increase in the depth of the GAC media from 30 inches to 38 inches, as well as the need to replace the media on four filters at the Lake Saltonstall Water Treatment Plant, project costs have increased. Amendment No. 24-49 will transfer \$651,000 from the West River Water Treatment Plant Improvements project account into the Filter Media Replacement project account.

The following resolution will be necessary to carry out the foregoing:

Resolved: that the Authority approves the transfer of \$651,000 from the West River Water Treatment Plant Improvements capital budget account to the Filter Media Replacement capital budget account.

The below transfers are to the Project Reserve and total \$4,315,000.

Lake Whitney Water Treatment Plant Ozone and DAF Controls: As a result of extended equipment lead times and significant delivery delays, the project will be under-expended in FY 2024. Amendment No. 24-50 will transfer \$550,000 from the Lake Whitney Water Treatment Plant Ozone and DAF Controls project account to the project reserve account to be held for FY 2025 for the Lake Whitney Water Treatment Plant Ozone and DAF Controls project.

Derby Wellfield Facility Improvements: As a result of extended equipment lead times and significant material delivery delays, this project will be under-expended in FY 2024. Amendment No. 24-51 will transfer \$1,100,000 from the Derby Wellfield Facility Improvements project account to the project reserve account to be held for FY 2025 for the Derby Wellfield Improvements project.

Lead Service Line Replacements: As a result of delays in obtaining necessary municipal permits to begin the planned vacuum excavation work, project expenditures will be less than originally anticipated. Amendment No. 24-54

will transfer \$1,250,000 from the Lead Service Line Replacement project account to the project reserve account to be held for FY 2025 for the Lead Service Line Replacement project.

CIS: As a result of a shift in the project schedule, invoice timing and associated payments has also shifted, resulting in an under-expenditure for FY 2024. Amendment No. 24-57 will transfer \$1,415,000 from the CIS project account to the project reserve account to be held for FY 2025 for the CIS project.

The following resolution will be necessary to carry out the foregoing:

Resolved: that the Authority approves the transfer of \$550,000 from the Lake Whitney Water Treatment Plant Ozone and DAF Controls project capital budget account, \$1,100,000 from the Derby Wellfield Facility Improvements capital budget account, \$1,250,000 from the Lead Service Line Replacement capital budget account, and \$1,415,000 from the CIS capital budget account to the project reserve account.
